POSITION SUMMARY:

This position supports the work of the Y, a leading nonprofit committed to strengthening community through youth development, healthy living and social responsibility. Develops, organizes and implements high quality YMCA child care program(s).

3. Works alongside staff to help achieve program goals, and makes the staff schedule, monthly and bus driver schedules weekly.
4. Must get the training to drive the van at least CDL preferred.
5. Assures compliance with federal, state and local regulations as they relate to program areas. Ensures that YMCA program standards are met and safety procedures followed.
6. Attends all food programming trainings, and helps implement HEPA standards
7. Is in charge of setting a schedule and helping with the cooking and food program. MUST work in the kitchen at least 3 days a week, and always on a full day out of school.
8. Provides for upkeep of assigned program facilities and equipment and ensures the physical environment supports healthy living.
9. Responds to all agency, parent and community inquiries and complaints in a timely manner.
10. Maintains proper records/department files.
11. Compiles program statistics. Monitors and evaluates the effectiveness of and participation in program.
12. Answers questions that members have in a timely manner.
13. Meets with the after school leadership team.
14. Attends all trainings and keeps staff accountable for their trainings.
15. Performs other duties as assigned.

5. Must complete YMCA Child Abuse, CPR, and First Aide trainings within 30 days of hire.
6. Must fulfill all State of Nebraska trainings within the State's required guidelines.
7. Ability to relate effectively to diverse groups of people from all social and economic segments of the community.
