3. Supervises the children, child watch area, and all activities including ADA accommodations where appropriate. Follows all procedures and standards.

5. Maintains program site and equipment.
6. Maintains required program records.
7. Hires and schedules program staff.
8. Attends and participates in family nights, program activities, staff meetings, and staff training.
9. Performs other duties as assigned.
